TUITION Payments are determined by the # of classes each student/immediate family member takes per month. Regardless of your means of payment, all classes must be paid for Before you take the class. If you choose to pay in full for the trimester, you will receive 10% off your tuition. Pay for the whole year, you will receive 15% off your tuition. Payment must be made the first week of first month to receive this discount. **Tuition payments are not refundable**

OPTION #1: Cash Payment: 1 class = \$35 mo., 2 classes = \$65 mo., 3 classes = \$95 mo., unlimited = \$130 mo. When cash payment is made, Option #1 is an automatically binding agreement to pay for a full trimester of classes. This automatically rolls over into next trimester at the same number of classes & cost unless a written note of change is given before the last week of trimester. Once new trimester begins, student is responsible for payment in full for entire trimester, regardless of their ability to attend classes. Ability to makeup a class does not extend beyond said month of missed class.

OPTION #2: Check Payment 1 class = \$40 month, 2 = \$75 month, 3= \$105 month, unlimited = \$140 Mo on or before the first day each month.

OPTION #3: Single classes \$12 per class. Ages 10 and up: Not an option for children's classes under age 10 (unless it's a one time visitor)

ADDITIONAL PRICING: Unlimited classes & pricing do not apply to workshops, camps, private lessons or classes through Adult Ed. Other restrictions may apply. Gemini Dance Company tuition is set at \$30 per month. Ability to make up missed classes does not extend beyond said month of missed class.

Student/Guardian must read & initial each line below

- *Tuition payment are due on or before the first day of each month or each class if taking single classes. \$5 late fee will be applied to all late payments per class, per week each week & every week thereafter until payment is received.....
- *All returned checks will incur a \$35 fee in addition to a \$5 late fee for each week until debt is settled. Additionally Student/Guardian is responsible for all legal fees, court costs, travel costs, time spent at a rate of \$25 per hour plus any other
- miscellaneous expenses incurred by the dance studio in an attempt to collect unpaid debt
- *We reserve the right to refuse entrance to anyone (student or guardians) due to safety concerns or inappropriate..... behavior. Student and/or Guardian is responsible for replacing broken items at current replacement cost of said item
- *Students with unpaid tuition may not be allowed to participate in class until said fees are paid in full or a payment..... arrangement has been made. Tuition will still be accruing along with applicable late fees during absence from class
- *Missed classes & tuition payments are not refundable.** Students should contact teacher or studio directly to..... inquire about attending another age appropriate make up class. Refer to studio policies for more details
- * Some classes may require specific clothing and/or footwear which must be purchased from dance studio vendors.....
- *Each student who is performing will need to purchase a Costume. Costume deposits of \$20 must be paid by the first week in March. Costume payments are non refundable. All costumes & accessories needed for the June recital..... must be purchased through Full circle Dance Studio, unless told otherwise by the instructor
